

**Victory Radio – Fall Victory Partner Days 2020  
Official Contest Rules**

NO PURCHASE NECESSARY. A PURCHASE, PAYMENT, OR DONATION OF ANY KIND WILL NOT  
INCREASE YOUR CHANCES OF WINNING.

1. **Eligibility:** The Victory 91.5 Mac Pack Giveaway, the Golf Outing Giveaway, the VIP Sloth Experience Giveaway, and the Car Care Pack Giveaway (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry ("Entrant(s)"). Employees and contractors of Victory 91.5 and War Hill Christian Fellowship, as well household members of each such employee, are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited.

  - b. Promotion Entry Period 2 begins on October 6, 2020 at 12:00 a.m. Eastern Time ("ET") and ends on October 9, 2020 at 11:59 p.m. ET (the "Promotion Period"). Administrator's computer is the official time-keeping device for this Promotion.
4. **How to Enter:** During each of the Promotion Periods, Entrants may call (770)781-9150 or visit <https://victory.radio/amoe> and submit registration including a valid email address, phone number and mailing address. The Victory 91.5 donation form automatically submits one (1) entry form on the user's behalf with each donation. Entries that are incomplete or do not adhere to the rules may be disqualified at the sole discretion of the Administrator.
  - a. **Limit:** Each Entrant may receive one (1) entry during the Promotion Period.
  - b. Multiple Entrants are not permitted to share the same email address. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that Entrant's entries/plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. 9. **Terms & Conditions:** The Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Promotion should virus, bug, non-authorized human intervention, fraud, or other cause beyond the Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Promotion. In such case, the Sponsor may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the Sponsor. The Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or

website or violates these Terms & Conditions. The Sponsor has the right, in its sole discretion, to maintain the integrity of the Promotion, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
